

## MARSY'S LAW

### As a victim you have the right to:

- Be informed, in writing, of your constitutional rights as a victim.
- Be treated with fairness and respect for your safety, dignity, and privacy.
- Reasonable protection from the accused or any person acting on his or her behalf.
- Reasonable and timely notice of all public proceedings involving the criminal offense or delinquent act (upon request).
- Be present at all public proceedings involving the criminal offense or delinquent act.
- Be heard in any public proceeding involving release, plea, sentencing, disposition, or parole, or in any public proceeding in which your rights as a victim are involved.
- Confer with the prosecutor (upon request)
- Proceedings free from unreasonable delay and prompt conclusion of the case.
- Refuse an interview, deposition, or other discovery request made by the offender or any person acting on the offenders' behalf-unless a court finds such a refusal violates the defendant's constitution rights.
- Receive a full and timely restitution from the person who committed the criminal offense or delinquent act against you.
- Reasonable notice of the offender's release or escape (upon request)

## VICTIM SERVICES RIGHTS AND RESOURCES GUIDE

## UC'S CRIME VICTIM SERVICES COORDINATOR CAN:

- Assist with making police reports
- Educate on victim rights and options
- Assist in filing for Orders of Protection through the courts in stalking, sexual assault and dating violence cases
- Accompany victim to court and meeting with police and prosecutors
- Provide transportation to court
- Help victims navigate through the criminal justice system
- Work with victims to assess needs, make connections and make referrals to the appropriate resources
- Assist in filing for victim's compensation
- Crisis intervention and safety planning
- Provide notifications of court proceedings and updates on cases
- Provide notifications to instructors when the victim must miss class due to criminal incident

## VICTIM RIGHTS REQUEST FORM

As a victim of crime, you have constitutionally protected rights. Some rights are automatic. Some rights require your request.

This form provides important information about your rights. This form is NOT a public record. You can choose to exercise all, some, or none of your rights, and you can change your selections at any time.

If you are a victim of a violation of a protection order, an offense of violence or a sexually oriented offense and the form is not completed, you will automatically be opted in to all "upon request" rights until you opt out or are contacted by the prosecutor.

This form can be done in person with law enforcement when an arrest is made or it can be completed online.
